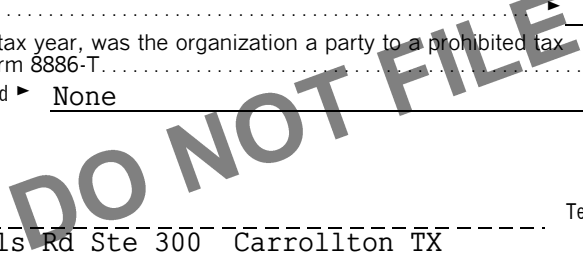

for many victims due to safety concerns. Ridesharing and Uber are not always an option either for victims that lack a phone or credit card, or fear their abuser will discover the transaction details. Transporting victims to arrive to shelter, or leave for family outside the local area, is beyond the scope of most domestic violence shelter agencies. Families to Freedom bridges that gap by providing no-cost, long-distance transportation for victims to arrive to shelters across North Texas or get to a family home across the country. Victims and new survivors are frequently referred to Families to Freedom through other agencies and civic professionals, including police agency crime victim advocates, Child Protective Services, domestic violence shelters, medical facility social workers, and counselors. We also receive calls directly from victims without referrals. Our response to each victim client is tailored to their fragile emotional state, exercising an acute sensitivity in understanding that they are abuse survivors and knowing they have unique travel needs. In 2019, Families to Freedom transported 554 people: 285 adults and 269 children. Drivers embarked on 199 roads trips to shelters and family homes. We purchased 63 bus tickets and 12 commercial flights for clients to reunite with family. Forty-four survivors used our fuel cards to drive themselves to family far away. Office team members spoke to 830 victims and survivors seeking help. 2019 marked our first year to begin receiving Office of the Governor state funds to support employee wages, insurance, office rent and the purchase of a vehicle. In 2018, approximately 80% of revenue received was from private, individual donations. In 2019, this ratio decreased despite an increase in total revenue dollars from this source. Income from other sources continue to support program expenses. Families to Freedom remains largely a volunteer organization with 80 people who transport victims, retrieve donated travel items, help with fundraising, and advocate in the community.
